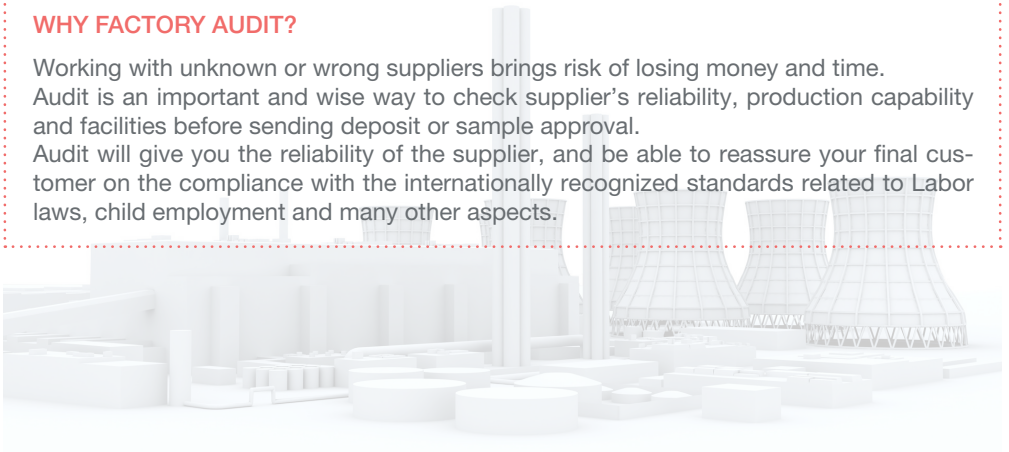

### WHY PRODUCT QUALITY CONTROL?

Answer is simple, poor quality brings more cost. Product control is the best method to secure your order and reduce the risks substantially. By inspecting, you can obtain the status of your production and accurate the situation before paying the balance.

The goal of quality inspection is early defects detection, support the delivery time lines, save time and cost.





### INITIAL PRODUCTION INSPECTION (IPI)

Visual inspect materials, components and products available at an initial stage of production.

### DURING PRODUCTION INSPECTION (DPI)

Control and recommend for production processes and capacity when 20-80% products finished. Both finished and semi-finished goods involved.

### PRE-SHIPMENT INSPECTION (PSI)

When goods are 100% finished, inspector randomly select samples according to international standard. Ensure the products are in accordance with your specification before loading.

### CONTAINER LOADING SUPERVISION (LSI)

Supervise whole loading process and randomly check goods specification. Ensure products are correct and loading safely.

### PRODUCTION MONITORING INSPECTION (PMI)

Continuous quality control on site everyday and gives you a report (daily) on the status of your production and quality.

### DEFECT INSPECTION (DI)

Efficient way to know the percentage of defective products in whole shipment and to ensure if your supplier really reworks the unqualified products correctly.
